Product Description: The HM50 is a negative pressure full face mask. It may be used as a normal full-face

respirator, using a conventional head harness. In this mode it is CBRN compliant. The HM50 may be used in conjunction with a riot helmet, which replaces the conventional head harness as the means of securing the respirator to the wearer's

face. The face mask is fitted with a drinks system

The HM50P variant is available without a drinks system.

1. Field of View: NIOSH CBRN requirement is used as this is aligned to military masks that need compatibility with optical sights

2. Filter ports: The second port in the twin port variant is always fitted with a plug that can only be fitted and removed by the use of a special tool. As the mask is designed for specialist user groups and is not available to general industrial users, closing the second port in this way, but still allowing the filter to be mounted left or right in the same mask
