Product description: The PC50 is a Full Face Mask designed specifically for specialist user groups including riot control officers, correctional facility officers, border control agents, Police officers and other first responders. It features two threaded filter connectors. The threaded filter connectors permit the mask to be reconfigured for left or right handed weapons firing. Technical Specification PC50 Rev 1 relates only to the mask in negative pressure mode, when one of the two threaded connectors is sealed with a plug. The plug requires a special tool for its insertion and removal. Trained personnel can reconfigure the mask from left to right-handed, or vice versa, depending on user operational needs
