The device has twin combined filter assemblies designed and constructed to enable the wearer to breathe ambient. The Escape Hood is available in 3 sizes and is intended to be used for very short-term emergency escape action, such as rescue, evacuation and escape in areas contaminated by chemical, biological, radiological and nuclear (CBRN) agents. The hood provides up to 15 minutes protection against airborne contaminants, including solid and liquid respirable particles, gases and vapours, it also provides protection against small splashes of liquid agents.
